I will arrange to meet with the LXRA and also raise this with the Minister for Transport. Ensuring a good outcome for bikes with the level crossing removals is a priority of mine. I don't want outcomes like Camp Road or Buckley St. What will you do to ensure that the East Brunswick Shimmy in John St is not adversely affected by the East Brunswick Village project? I have already been pushing for improvements in the shimmy, specifically at the intersection of Glenlyon and John St where bike and pedestrian traffic is expected to increase when the Village is complete. A cyclist was recently hit by a car here and I think lights or a reduction in speed limit are required. It's important that most car traffic from the Village be directed to Nicholson St rather than the shimmy. The bike lanes on John St were never wide enough and increasing width to account for dooring zones should be considered.

I have promoted the idea of a separated bike lane along Sydney Rd from Bell St to St Kilda. But we shouldn't restrict this to Sydney Rd. I believe Brunswick can become a cycling neighbourhood and used as an example for the rest of Australia. We can't make our streets wider but we can move more people by bike and public transport than we ever will by car. We need to win back more of our city from cars and we can start by legitimising bikes as a mode of transport, rather than something you give your kid for Christmas.
